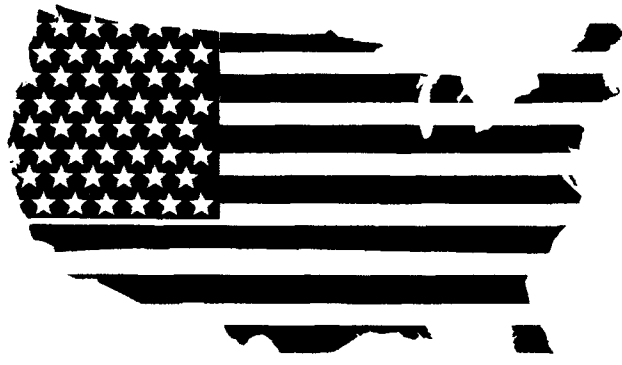

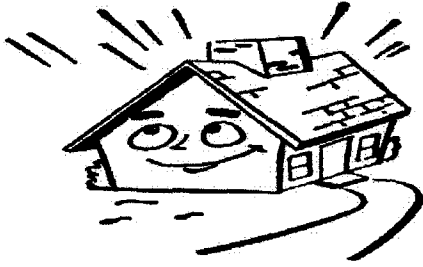

A spring welcome to you -- our advertisers, subscribers and readers! Be sure to read about the Extortion Attempt in this issue. One must be ahead of the scammers!

Just a reminder to you we cannot place advertising on a certain page. Many advertisers want the second page, but we don't have enough second pages. So, to be fair we place ads where we can.

One of our advertisers got a poorly written note about an order that was not received. The note writer claimed he did not get an order which was place over a year ago for \$5. His note was sloppy and included a claim that he was going to report them to the FBI. He said he even worked for them!!! This was sent before April Fool's Day. Could there be a connection? Beware of such false claims!

The ADVENTURE MARKETING publication has increased its circulation and their prices are going up slightly for ads. These issues are going out standard mail instead of first class as well. This allows them to increase circulation! See the new ad in this issue following this editorial.

If you are worried about your advertising being printed simply go online to www.ShoreToShore.biz and check. I know some people would rather email me than go look for themselves. The past issues are available online as a courtesy and many of our readers are happy to go online rather than get printed issues.

Please take care when sending in your full-page advertising. You MUST leave a ¼ inch margins on all sides for our equipment to properly scan it. Also take care to send advertising that is straight on the page. We print what we receive as camera ready. I know it is easy to get anxious over a deadline or anxious, but a few extra minutes will assure your advertising is the best it can be for your business.

You would not believe how many people want a FREE issue of this magazine each month. It can be seen FREE at www.ShoreToShore.biz otherwise there is a fee if you want a printed issue. The cost of postage, printing and assorted labor charges prohibits free mailings.

I have been very happy with several programs and you will see full page flyers in this issue.

Remember if you write to a dealer with questions please send an LSASE. It is common courtesy and good business. If you don't want a reply, then just don't bother sending an LSASE!

Would you like 30 fresh names/addresses from our incoming mail? Just send a LSASE by May 5, 2019!

I often see people pay a large amount of money to join a program and then don't promote it. I wonder why? Do they expect others to promote it for them? Most successful programs succeed when people work together as a team. Just like in any sports program one or two players cannot carry the team without complete team support.

If you have a computer, you may find submitting and paying for your ads very easy by going to www.ChaSvc.com You can upload your pdf and pay via PayPal. Quite a few of our advertisers have found this very effective and know their advertising will be here before the deadline.
